To Warden Jeffery E. McGill:

I am writing to express my concern about the serious violations of the rights of Mr. Avelino González Claudio, an inmate at your facility, and the cruel and inhumane treatment he is currently being subject to.

Mr. González Claudio has been placed in Maximum Security where he has not been allowed to communicate with his legal counsel or family members. Subjected to solitary confinement pending due process he remains in total isolation for 23 hours a day. Mr. González Claudio has been denied his rights to visitation by his family and his right to regular and timely access to legal counsel.

This treatment is a flagrant denial of his basic legal and human rights as a prisoner awaiting trial. This treatment is also seriously detrimental to Mr. Gonzalez Claudio's physical and psychological health.

In order to ensure Mr. Gonzalez Claudio's health, I insist that he be placed in general population, receive/make telephone calls, and be allowed visitation by family and friends.

You can be sure that I will continue to monitor his situation until he is granted his legal and human rights. I look forward to hearing your response.

Le escribo para expresar mis serias preocupaciones sobre las violaciones de los derechos de el Sr. Avelino González Claudio, un detenido en su penitenciaro, y el tratamiento cruel e inhumano al cual el está sometido en estos momentos.

El Señor González Claudio esta confinado bajo condiciones de Seguridad Maxima adonde no se le permite comunicarse con sus abogados or familiares. El está sujeto a confinamiento solitario antes de su juicio y se mantiene en aislamiento total las 23 horas al día. El Sr. González Claudio has sido negado su derecho a las vistas de su family y negado su derecho a comunicarse con sus abogados.

Este tratamiento constituye una seria violación de sus más basicos derechos legales e humanos como un confinado esperando juicio. Este tratamiento es ademas un serio deterioro a la salud fisica y sicologica del Sr. González Claudio.

Para asegurar la salud y bienestar del Sr. González Claudio, insisto que el sea trasladado a población general y que sus derechos a representación legal y las visitas de familiares y amigos sean respetadas.

Usted puede estar seguro que yo continuare monitoreando su situación y laborando para que se les respeten sus derechos humanos y legales. Espero ansiosamente su repuesta.
